# Position: Treatment Director and Clinical Supervisor, IRTS (Clinical Director)

## **Position Philosophy:**

The Intensive Residential Treatment Services (IRTS) Treatment Director will also function as the Clinical Supervisor and is responsible for implementing and coordinating the residential mental health and substance use services in our IRTS. The Treatment Director, also referred to as the Clinical Director, will provide oversight and direction to the staff and will ensure compliance with state and federal regulations.

## **Responsibilities and Duties:**

The treatment director will serve as the clinical supervisor. The treatment director will comply with items (i) through (iv).

- (i) The treatment director will be a mental health professional.
- (ii) The treatment director will know and understand the rules and regulations associated with the delivery of services under this variance. The treatment director will ensure that:
  - (A) The staff requirements in section, R36V.09, subdivision 1 and section R36V.10, subdivisions 1 and 3 are met;
  - (B) Staff understand how to implement the recipients' ITPs, including all revisions to the ITPs; and,
  - (C) The development and revisions to the recipients' ITPs are in compliance with section R36V.04, subdivision 3.
- (iii) The services provided to recipients promote individual choice and involvement in the treatment process and that recipient rights are upheld.
- (iv) The treatment director determines the scope of interaction and involvement that is appropriate for volunteers to have with recipients in the program and is responsible to assure that the activities and functions performed by volunteers are directed and monitored appropriately.
- Will participate in weekly meeting with the management team.
- Be available for after-hour calls as needed.

#### Requirements:

The Treatment Director/Clinical Supervisor will be a mental health professional and will be a person able to provide clinical services in the treatment of mental illness and who is qualified in at least one of the following ways:

- (1) in psychiatric nursing: a registered nurse who is licensed under sections <u>148.171</u> to <u>148.285</u>; and:
  - (i) who is certified as a clinical specialist or as a nurse practitioner in adult or family psychiatric and mental health nursing by a national nurse certification organization; or

- (ii) who has a master's degree in nursing or one of the behavioral sciences or related fields from an accredited college or university or its equivalent, with at least 4,000 hours of post-master's supervised experience in the delivery of clinical services in the treatment of mental illness;
- (2) in clinical social work: a person licensed as an independent clinical social worker under chapter 148D, or a person with a master's degree in social work from an accredited college or university, with at least 4,000 hours of post-master's supervised experience in the delivery of clinical services in the treatment of mental illness;
- (3) in psychology: an individual licensed by the Board of Psychology under sections <u>148.88</u> to <u>148.98</u> who has stated to the Board of Psychology competencies in the diagnosis and treatment of mental illness;
- (4) in psychiatry: a physician licensed under chapter 147 and certified by the American Board of Psychiatry and Neurology or eligible for board certification in psychiatry, or an osteopathic physician licensed under chapter 147 and certified by the American Osteopathic Board of Neurology and Psychiatry or eligible for board certification in psychiatry;
- (5) in marriage and family therapy: the mental health professional must be a marriage and family therapist licensed under sections <u>148B.29</u> to <u>148B.39</u> with at least two years of post-master's supervised experience in the delivery of clinical services in the treatment of mental illness:
- (6) in licensed professional clinical counseling, the mental health professional shall be a
  licensed professional clinical counselor under section <u>148B.5301</u> with at least 4,000
  hours of post-master's supervised experience in the delivery of clinical services in the
  treatment of mental illness; or
- (7) in allied fields: a person with a master's degree from an accredited college or university in one of the behavioral sciences or related fields, with at least 4,000 hours of post-master's supervised experience in the delivery of clinical services in the treatment of mental illness.
